Kingsbridge IR35 Assessment Tool & Interactive Workshops

It has been confirmed that revised IR35 'Off-payroll...' legislation will indeed be introduced in April 2021 and all assignments (and indeed contractors) will need to prove their employment status to ensure that they comply with the guidance.

With this in mind, DASA Umbrella has partnered with Kingsbridge to provide agencies with access to their state-of-the-art online tool which accesses the IR35 status of any given assignment. It is vital that agencies introduce a compliant mechanism into their processes and procedures to demonstrate that they are actively adhering to the new guidelines.
